ASSOCIATES

Platinum Members – An exclusive membership category reserved for the motorcoach manufacturers (also known as OEM’s) and major distributors of motorcoach. It represents a combined membership and sponsorship contribution in support of FMA activities.

Silver Members – A membership category for suppliers of motorcoach products and services, including component manufacturers and suppliers whose retail products are commonly bought and used by motorcoach operators as well as significant bus-affiliated destinations and corporate chains that enthusiastically support FMA’s mission.

Emerald Members - Bus-related entities such as component manufacturers, consultants and suppliers whose retail products are commonly bought and used by motorcoach operators.

Bronze Members – Bus-related vendors such as CVBs, casinos, hotels, attractions, restaurants, travel destinations are the only groups eligible for this level of FMA membership.
